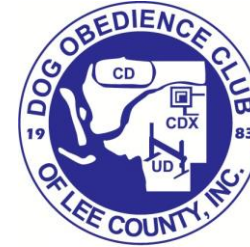

ENTRY FEE: \$65.00 per entry (including a \$3.50 Recording Fee and Event
Service Fee in accordance with Dog Show Rules, Chapter 11, Section 2).
Entry fee does not include the fee to enter the Wildlife Management Area.

ENTRIES: Entries must be on official AKC entry forms or photocopy
including the reverse side with agreements/rules. Entry form must be signed.

DRAW FOR TD TRACKS: The draw for running order of tracks will be on
Sunday, April 22, 2018, at 7:00 AM near the first building on the right after
turning on Webb Lake Road. The first track will be run following the draw.
In the event an accepted entry is absent, the first attending alternate by the
drawing will participate, and so on.

ELIGIBILITY FOR TD TEST: The Tracking Dog Test (TD) is only for
dogs that have passed a tracking certification, under a licensed AKC judge,
within 12 months prior to the date of the test. A statement of certification
must accompany each entry for dogs that have not earned a TD or TDU.

BITCHES IN SEASON MAY PARTICIPATE: It is the responsibility of
the entrants to notify the Test Secretary and judges that their bitch is in
season prior to the drawing for tracks. Bitches in season will participate only
after all other dogs have been tested.

AWARDS: Handlers and dogs marked "Passed" by the judges will receive
the final article signed by the judges, a green rosette ribbon and a certificate
issued by the AKC.

IMPORTANT NOTE: The Babcock/Webb Wildlife Management Area
requires a permit for those under 65 years of age. Daily Use permits are
available for \$3.00 at the entrance.

ATTENTION EXHIBITORS and SPECTATORS: Dogs shall be "on
lead" at all times on any areas of the tracking site. A dog that is allowed to
run off lead, at any time before the test, during the test, after failing or after
the completion of its track, shall be failed and excused. If this occurs before
the test, the dog shall be excused and not allowed to test.

DIRECTIONS: Take I-75 exit 158 and head east. Turn right at Webb Lake
Road and turn right at the first driveway.
